

# Approved Minutes of Scottish Antimicrobial Prescribing Group Committee Meeting held on Tuesday 06 February 2024 at 1-3pm via MS Teams

#### 1. Welcome, apologies for absence and declaration of interests

The Chair opened the meeting and welcomed everyone.

## 2. Minutes and actions from previous meeting (papers 1,2)

The minutes of the meeting held on 12 December 2023 were accepted as an accurate record.

## 3. Review of recent trends in antibiotic use in primary care – presentation

Most recent data presented on the trends in antibiotic use in primary care in Scotland. The presentation focused on recent trends on use of antibiotics commonly used for respiratory infection, antibiotic use in dentistry and progress against antibiotic use indicators.

The SONAAR team will arrange for issue of NHS board reports to be issued after the meeting. The SONAAR Programme will continue to monitor and issue e-message weekly reports to SAPG and AMTs.

## 4. Gentamicin reporting in Pseudomonas aeruginosa – presentation

Reported in microbiology laboratories across the UK, gentamicin has routinely been tested and susceptibility results reported for Pseudomonas aeruginosa. EUCAST removed gentamicin breakpoints in 2020 and sensitivity testing was then based on Clinical & Laboratory Standards Institute (CLSI) America gentamicin breakpoints, and these too have now been removed. SMVN recognise that it's difficult to report gentamicin sensitivity for Pseudomonas, however, gentamicin is used frequently as empiric treatment.

## SMVN recommendations and strategy

- Laboratories continue to test gentamicin in Pseudomonas aeruginosa but utilise previous breakpoints rather than the ECOFF.
- Gentamicin resistance is reported to clinicians.
- Where gentamicin is susceptible according to previous breakpoints, laboratories can choose
  to report this result but a supporting comment is recommended to indicate that whilst no
  acquired resistance to gentamicin has been detected other agents are more active.
- In significant Pseudomonas infection, other aminoglycosides are preferentially reported.

SAPG Committee supportive of SMVN recommendations.

#### Items for discussion and agreement:

#### 5. **OPAT Guidance**

#### • **OPAT LUTI pathway** (paper 3)

Pathway was created for management of resistant lower urinary tract infections with no oral options for treatment in a non-inpatient setting. Has been approved by OPAT group with minor amendments.

#### Good practice prescribing guide (GPPG) (paper 4)

OPAT group have created abbreviated versions of GPPGs even those which are currently published. Asked Committee for any comments on ceftazidime, ceftriaxone, dalbavancin, daptomycin, ertapenem and piperacillin/tazobactam (30 mins IV infusions). Three more are being finalised by the OPAT group; meropenem, piperacillin/tazobactam (24 hour infusion) teicoplanin and amikacin.

Committee happy with the six proposed antibiotics guidance and further antibiotics will come back to the group once reviewed by SAPG OPAT group.

## 6. Good practice recommendations for antimicrobial use in frail older people (paper 5)

Guidance updated after comments received at previous meeting. Edited and layout may look different.

Group happy to accept document with update on quinolone included.

#### Items for update:

7. Transfer of antimicrobial companion app content to Right Decision Service (RDS) app (paper 6)
Antimicrobial companion app is closing and antimicrobial content is moving to RDS app.
Antimicrobial companion app was built on an older RDS platform and that has now reached its end of life and is no longer sustainable. The relaunched calculators will be UKCA accredited.
Confirmed it's not mandatory for health boards to move their content.

## 8. Neutropenic sepsis guidance update

GGC have updated the guidance and now needs to be shared nationally for cross disciplinary and cross board input. Requires a short life working group (SLWG) to be created and representation from ASAP, haemato-oncology and other centers with important barriers.

#### 9. SIGN 104 and SIGN 160

Chair of SIGN 104 advised of a joint collaboration with SIGN and SAPG to update the guideline. First meeting will take place in March and have full membership with professional and geographical representation. SIGN 104 was published in 2008

Chair advised SIGN 160 is also due for review. SIGN carried out a literature search to review all the data and evidence. Findings have been shared with members of original group.

## 10. HEPMA update

National process for HEPMA to be updated to enable the system to record the indication for the antibiotic. Created a draft document which could potentially be introduced into HEPMA. Shared with GGC colleague who is leading on HEPMA. GGC system has already been enabled to introduce this and will be able to see what is feasible and if can be adapted. Will then bring back to SAPG for discussion.
